Is your Workforce highly engaged?

Have you reviewed your Employee Value Propositions?

The latest global study by 'Towers Watson' (Global Workplace Study – At a Glance 2012) of 32,000 employees around the world shows a workforce struggling with the impact of financial pressure and constant change. Employees are anxious, worried about their futures and becoming risk-averse. For employers, this heightens performance risk – lower productivity, higher inefficiency, greater rates of absenteeism and turnover affected by the increased costs of illness.

Crucially, staff engagement is plummeting, with only 35% of the workforce deemed to be highly engaged. Should you be worried by this? Yes – there is a very strong relationship between high levels of engagement and company financial results.

To put it simply, nearly two-thirds of employers are using old ideas, managing costs and expecting more from less, to ride out the current economic storm. This creates two problems you won't be able to effectively manage through the current economic climate and it impacts on levels of employee engagement which then impacts on financial results. You can envisage the downward spiral and then consider that one-third of employers are visionary. What are they doing that you may not be doing and how does their visionary leadership benefit the company? Will your company be able to compete, or even to exist in the future with your current ideas?

To answer these questions you need be aware of what makes employees tick. To do that you need to look at the Employee Value Proposition (EVP) for each employee. EVP is the balance between the rewards and benefits that employees receive in return for their performance. EVP encompasses colleagues, culture, jobs, mission and values as well as rewards.

I started this article by posing two questions which are intrinsically linked. Neither outcome can be achieved independently. There are three elements to sustainable engagement: the employee's willingness to expend discretionary effort on the job; having the tools, resources and support to do their job effectively; and having a work environment that actively supports physical, emotional and interpersonal well-being.

Senior Managers/Executives need to change their mind-sets and ideas to weather the ups and downs if they are to lead organisations effectively both now and in the future and provide employees with stability and direction.
