### **Examination Format**

Candidates will be presented with a scenario where they assume the role of a manager, a person responsible for a department they wish to develop, or someone facing organizational challenges within their affiliated organization. Candidates are required to present management issues and problem-solving methods, or opportunities for business development (by integrating management theories and applying them in practice). The presentation will be made to the examination committee, followed by a Q&A session, with the total time allotted for the presentation being no less than 20 minutes.

Candidates must prepare a situation summary, printed on a single A4-sized page, to accompany their presentation. During the presentation, the use of any media tools or communication devices is strictly prohibited. In cases where candidates are not affiliated with any organization or cannot use data from their organization for the presentation, they may use data from another organization as a substitute. Dress Code Students must dress neatly and appropriately (shorts are not allowed) and must wear closed-toe shoes.
